

If you wish to have a lawyer, but believe you cannot afford one, call Kaleigh Bower at the Court of Common Pleas, Pickaway County, Ohio, Juvenile Division at 740-474-3117 between the hours of 8:00 AM and 4:00 PM, Monday through Friday, or write the Court of Common Pleas, Pickaway County, Ohio, Juvenile Division at the Pickaway County Courthouse, 207 South Court Street, Circleville, OH 43113.
2. The granting of the Complaint and prayer for temporary custody to PCJFS or another interested party will result in the Parent(s) losing physical and legal custody of the Minor Child until the Court terminates the order or permanently divests the Parent(s) of all parental rights.
3. The granting of an order of protective supervision to PCJFS may result in the Parent(s) continuing to have physical and legal custody of the Minor Child under the supervision of PCJFS until the Court terminates the order or grants temporary custody to PCJFS or another interested party.

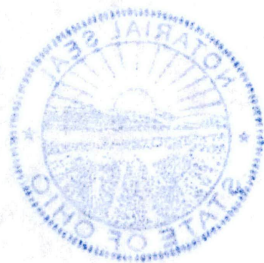

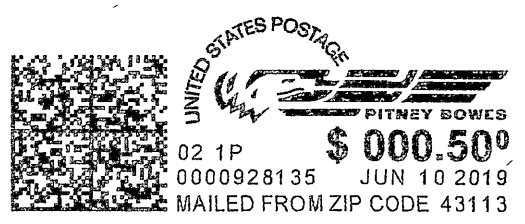


