

1. Post copies of the Motion, Affidavit in Support of Temporary Custody, Parenting Proceeding Affidavit, Notice of Final Hearing, and Notice of Posting upon Defendant, Shaun Shouldis, the biological father of Shaun Patrick Arthur Shouldis, DOB July 23, 2013 on the Pickaway County Juvenile Court website, in the section designated as "Public Notices".
2. The notice shall contain the name and address of the court, the case number, the name of the first party on each side, and the name and last known address of, if any, of the person or persons whose residence is unknown. The notice shall contain a summary statement of the object of the complaint and the demand for relief.
3. This notice shall be posted for six (6) consecutive weeks.

4. The clerk shall also cause the motion and accompanying pleadings to be mailed by ordinary mail, address correction requested, to the person's last known address. The clerk shall obtain a certificate of mailing from the USPS. If the clerk is notified of a corrected or forwarding address within the six-week period that notice is posted, the clerk shall cause the complaint and summons to be mailed to the corrected or forwarding address. 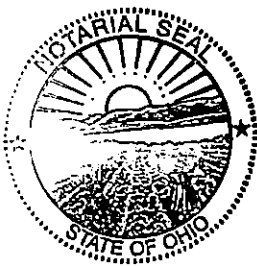
